

**CORPORATE ADVISORY- RELIEF MEASURES IN GST COMPLIANCES,
INCOME TAX AND MINISTRY OF CORPORATE AFFAIRS (MCA)**

Introduction

The Government of India has announced various relief measures for taxpayers under the GST Law, Income Tax and Corporate Affairs, keeping in mind the surging COVID-19 cases across the country. The summary of the benefits offered are explained further in this advisory.
